



## Limited Warranty

This warranty applies to Aguiar Pavers, LLC. Installation services described herein only.

### Limited Warranty.

Aguiar Pavers warrants, ("Limited Warranty") to the original property Owner who contracted directly with Aguiar Pavers only. Warranty is non-transferrable. For non-homeowner solicited projects where a Contractor has hired Aguiar Pavers to install pavers the Limited Warranty is 1 Year from the date of installation.

For paving stones, if within 20 years of the completion of work, the workmanship of the installation fails to conform to our installation quality specifications, we will, at our election, repair or replace the products at our own expense.

For Turf, if within 10 years of the completion of the work the workmanship of the installation fails to conform to our installation quality specifications we will, at our election, repair or replace the products at our own expense.

For mortared walls, natural stone or manufactured stone, pool coping, fireplaces, fire pits, barbecue islands or other outdoor elements; masonry; and tiling; if within 2 years of the completion of the work, 1 Year for lighting, the workmanship of the installation fails to conform to our installation quality specifications, we will, at our election, repair or replace the products at our own expense.

### Terms and Conditions

This Limited Warranty is only applicable where the Pavers were sold through Aguiar Pavers; is not removed or relocated from its original installation location; is used in compliance with the Pavers specifications; and is subject to the other limitations and exclusions set forth herein.

This warranty does not cover any damage caused by occurrences beyond the control of Aguiar Pavers. Notwithstanding anything to the contrary, this Limited Warranty does not apply to failure of, damage to, or deterioration (including without limitation color or texture changes) of the Pavers resulting from:

- ❖ Events of force majeure, including without limitation storm, flood, hurricane, earthquake, tornado, lightening, fire, volcano or other acts of god; collision, vandalism, war, civil unrest, or other accidental or intentional events;
- ❖ Deterioration from the effects of acid rain or other pollution;
- ❖ The use or application by third party of sealers, cleaners, or cleaning practices not consistent with Industry Specifications;

- ❖ The use of polymeric sands from third parties.
- ❖ Naturally occurring efflorescence of pavers, stains, or any damage due to uncontrollable circumstances.
- ❖ Changes made to the Pavers products or their installation by anyone other than Aguiar Pavers.
- ❖ New excavation, digging or soil removal occurs within one foot of finished Pavers.
- ❖ Use of high pressure water above specification to clean the surface or joint lines of the pavers.
- ❖ Damage caused by tree and/or shrub roots to the Pavers. This Guarantee does not cover normal maintenance, such as cleaning, weed removal and turf grooming or changes in lighting caused by changes in landscaping or vegetation growth.

If a warranty claim is made, it must be submitted within the warranty period. If you wish to have another company complete the repairs, we do not reimburse you or others for the repairs, and the warranty is void.

You must notify us of any failure as soon as you become aware of it. We will not be responsible for repairing additional damage due to defective conditions not timely corrected.

If we must replace products, we cannot guarantee a color match.

**Late payment:** All final payments are due upon completion of work. Late payments for paver's projects will result in the termination of the warranty.
